### Hurricane Preparedness for People with Disabilities

The Governor's Division of Emergency Management has developed new resources to help people with disabilities prepare to safely leave evacuation zones during this year's hurricane season, which begins June 1 and lasts through November 30.

The resources include three advisory documents and a pre-registration system for transportation during an emergency.

The documents are:

Your Emergency Evacuation Kit, a checklist of what is required in an emergency kit for special health care needs;

Planning for Emergencies, how-to tips on learning about community resources, creating a support network, and more; and

Preparedness Websites, a list of sites that offer planning and preparedness information for Texans with disabilities.

Pre-registration for transportation assistance during hurricane evacuation is being coordinated by the Texas 2-1-1 Information Referral Network. People with special needs who cannot evacuate by themselves or do not have friends or family to help in an evacuation can call 2-1-1, and the information they provide will be shared with local emergency officials in evacuation zones. Texas evacuation zones include 22 counties: Aransas, Brazoria, Calhoun, Cameron, Chambers, Galveston, Hardin, Harris, Jackson, Jasper, Jefferson, Kenedy, Kleberg, Liberty, Matagorda, Newton, Nueces, Orange, Refugio, San Patricio, Victoria and Willacy.

Do you know how to find information about brain injury, where to look?

Have you looked at the BIATX **website** lately?

Many new resource sites have been added to assist you in finding the information you need.

Calls in to the brain injury hotline seeking assistance are coming in because of referral from members like you. When asked if they have checked the web site for the information, many callers report they were not aware there was a web site.

You can make a difference. Some association members have begun **visitation programs** to hospital neurology units to help newly injured individuals & their families through times of crisis. Do you want to help? We will help train you & provide

resources. You invest the time!

Advocacy: Our effectiveness depends on having resources available. If funding is cut, resources for brain injured families will be hard to replace. Check the **public policy web page** and sign up for the E-mail notices. Stay informed! Once you know how you feel about an issue, use our web site to contact your district legislators and advocate for persons with brain injury. Let them know you care & you vote on the issues you care about.

Military families of Afghanistan & Iraq veterans need your support. The war is producing more head injured survivors than any previous war. Soldiers & civilian war workers are surviving injuries that

caused death in the past due to improved medical care & rapid onset of that care. As these families return to their home communities the military injured will be able to receive some care from the military hospitals. Reintegration into previous jobs or retraining will require family and home town community support. Rehabilitation programs for civilian returnees will be needed. Their family members will need support in adjusting to personality changes that result from injuries.

## New TBI Findings Released by CDC

According to new findings released recently by the Centers for Disease Control and Prevention (CDC), direct medical costs and indirect costs such as lost productivity of traumatic brain injury (TBI) totaled an estimated \$60 billion in the United States in 2000.

The new data and findings were released in the book *The Incidence and Economic Burden of Injuries in the United States*, by scientists from the CDC, as well as scientific research contractors at RTI International and the Pacific Institute for Research and Evaluation. Continued...

## Continued from Page 1 – New CDC Findings:

This groundbreaking book examines the lifetime time costs associated with the injuries that occur in just one year. In 2000 alone, the 50 million injuries that required medical treatment will ultimately cost \$406 billion. These total costs, for both fatal and nonfatal injuries, include estimates of \$80.2 billion in medical care costs and \$326 billion in productivity losses, which include lost wages and the accompanying fringe benefits, as well as the lost ability to perform normal household responsibilities.

The authors also examine medical expenses and productivity losses by gender, age, mechanism of injury, body region and body part injured, and severity. Findings include:

- Males account for approximately 70% (\$283 billion) of the total costs of injuries.
- Persons aged 25 to 44 years represent 30% of the U.S. population and 40% (\$164 billion) of the total costs of injuries.
- Motor vehicle and fall injuries account for 22% (\$89 billion) and 20% (\$81 billion) of the total costs of injuries.
- Upper extremity and lower extremity injuries each account for 17% (\$68 billion) of the total costs of injuries.
